- The bids will be opened in the presence of Bidder's representatives who choose to attend at 14:00 hours (local time) on 28/04/2023 at the Office of the Auditor General, Anamnagar, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 87,500.00, which shall be valid for 30 days beyond the validity period of the bid.
