Interested bidders shall register in the e-GP system and deposit the nonrefundable fee of bidding document Rs. 5,000.00 (In words Nepali Five Thousand Only) in the following Rajaswa (revenue) account as specified below.

- A pre-bid meeting shall be held at Office of the Auditor General, Babarmahal, Kathmandu at 5. 13:00 hour (local time) on 28/09/2021
- Electronic bids must be submitted to Office of the Auditor General, Babarmahal, Kathmandu 6. through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hour (local time) on 08/10/2021. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 7. hour (local time) on 08/10/2021 at Office of the Auditor General, Babarmahal, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of NRs. 9, 42,000.00, which shall be valid for 30 days beyond the bid validity period (90+30=120days).
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such a case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
