Bidding is open to all eligible Nepali Bidders.

The Office of the Auditor General Nepal invites an electronic bid from eligible bidders for the procurement of Supply and Installation of Furniture for the Newly Constructed Office Building of Office of the Auditor General, Anamnagar, Kathmandu under National Competitive Bidding procedures specified in the Public Procurement Act and Regulations.

Interested bidders shall register in the e-GP system and deposit the non-refundable fee of bidding document Rs. 5,000.00 ( In words Nepali Five Thousand Only ) in the following Rajaswa (revenue) account as specified below.

5. A pre-bid meeting shall be held at **Office of the Auditor General, Babarmahal, Kathmandu at 13:00 hour (local time) on 28/09/2021**
6. Electronic bids must be submitted to **Office of the Auditor General, Babarmahal, Kathmandu** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hour (local time) on 08/10/2021**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hour (local time) on 08/10/2021** at **Office of the Auditor General, Babarmahal, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of **NRs. 9,42,000.00**, which shall be valid for 30 days beyond the bid validity period (90+30=120days).
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such a case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Office of the Auditor General of Nepal reserves the right to accept or reject the bids without assigning reason, whatsoever.
