Interested bidders shall register in the e-GP system and deposit the non-refundable fee of the bidding document of Rs. 3,000.00 (In words Nepali Three Thousand Only) in the following Rajaswa (revenue) account as specified below:

4. Electronic bids must be submitted to the **Office of the Auditor General, Anamnagar, Kathmandu** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours on 28/04/2023**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidder's representatives who choose to attend at **14:00 hours (local time) on 28/04/2023** at the **Office of the Auditor General, Anamnagar, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 87,500.00**, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. Office of the Auditor General of Nepal reserves the right to accept or reject the bids whatsoever be assigning reason.
