Invitation for Bids for Second Floor Renovation Work

1. In accordance with its annual program and budget, approved by the GON, Office of the Auditor General , Nepal (OAGN), Babarmahal, Kathmandu intends to apply a portion of allocated budget to eligible payments under the contracts for **Second Floor Renovation Work** at Babarmahal as mentioned in table below and invites sealed bids from eligible bidders for the below mentioned works. Bidding is open to all eligible Bidders.
2. The interested bidders can bid either as a single entity or in joint venture. The maximum number of JV Partners is limited to 3.
3. Eligible Bidders may obtain further information and inspect the Bidding Document at the office of the AGN, Babarmahal, Kathmandu, Telephone no: **4262798,4262415 Fax: 4268309.**
4. A Complete set of Bidding Document may be purchased from the office of AGN ,Babarmahal, Kathmandu by the eligible Bidders on the submission of a written application, along with the verified (Certified) copies of company/firm registration certificate, Tax registration, Tax clearance F/Y 2073-074 and upon submission of bank voucher of non-refundable document fee as mentioned in table below up to **31 January, 2017** . For bank receipt the fee shall be deposited in **Rastriya Banijya Bank, Teku, Bank (Revenue) Account No. 1-1-001. Name of office OAGN, Office code No. 27-208-01, Revenue Head No. 14227.**
5. Sealed bids must be submitted before 12:00 A.M. of **29 November 2017**. Documents received after this deadline will be rejected. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 2:00 P.M. on **29 November 2017** at the office of the AGN, Babarmahal, Kathmandu .
6. Bids must be valid for a period of 45 days after bid opening and must be accompanied by bid security, amounting to the sum mentioned in table below which shall be valid for minimum 75 days from the day of bid opening. If bidder wishes to submit the cash security, the cash should be deposited in the **district Treasury Office, Tripureshwor, Kathmandu (Kosh Tatha Lekha Niyantark ko karya's) Dharauti Account at Rastriya Banijya Bank, Teku Dharauti Account No1201200001002524.**
7. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
8. If the last date of bid form purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. Pre-bid meeting shall be held at OAGN, Babarmahal, Kathmandu on 11:00 A.M. on **22nd November** 2017. Bidders are requested to attend the meeting.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatever.
