- 5. Pre-bid meeting shall be held at **Office of the Auditor General, Babarmahal, Kathmandu** at **14:00** hour (local time) on 17/12/2021
- 6. Electronic bids must be submitted to the **Office of the Auditor General, Babarmahal, Kathmandu** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hour on 31/12/2021**. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hour** (local time) on 31/12/2021 at the Office of the Auditor General, Babarmahal, Kathmandu. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 5,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
