- 4. Bidding documents may be purchased from the above office of the Auditor General, Babarmahal, Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 3000. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 500. However, the Employer will not be responsible for delay or non-delivery of the documents so sent
- 5. Sealed Bids must be submitted to the above office of the Auditor General, Babarmahal, Kathmandu on or before [12:00 Noon] on [January 1, 2014 (2070/9/17)]. Documents received after this deadline shall not be accepted.
- 6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at [13:00 P.M. on January 1, 2014 (2070/9/17)] at the office of the Auditor General, Babarmahal, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a Rs. 375,000 (in words, Rupees Three Hundred Seventy Five thousands), which shall be valid for 30 days beyond the validity period of the bid. Bidders, who wish to participate in a single slice shall furnish bid security as follows:

For bid on Slice A Rs.65,000.00 For bid on Slice B Rs.205,000.00 For bid on Slice C Rs.105,000.00

- 7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- 9. The bidder may submit the bid for single or more slices as mentioned below and offer discounts/ cross discounts. Evaluation will be done slice by slice basis, with contracts awarded based on the award combination that is of least cost to the Purchaser.
